



Hancock County Conservation Board Crystal Lake Park Cabin Information

The Hancock County Conservation Board has three log cabins available for the public to rent at Crystal Lake Park as a perfect way to enjoy the comforts of home in a real log cabin. The cabins offer a special place to make lasting memories and enjoy the peaceful natural setting of Crystal Lake. Weather permitting, the cabins are available from April 15th to November 15th by reservation. Crystal Lake Park is located along the east lake shore of Crystal Lake at 1045 320th Street, approximately one half mile north of Crystal Lake, Iowa.

HOW TO RESERVE

- Call 641-923-2720 or email hancockccb@gmail.com with your contact information and the dates you would like to reserve a cabin.
- If the dates you request are available, HCCB will send you a Cabin Reservation Request Form & Responsibility Agreement. The agreement will need to be completed and returned by the deadline date given. The rental fee and damage deposit must also be returned at this time.
- HCCB will then send you a Reservation Confirmation Agreement. Your reservation is not complete until you receive this.
- Reservations can be made one year in advance.

CABIN RENTAL FEES/TAX, DAMAGE DEPOSIT POLICY, CHECK-IN & CHECK-OUT TIME POLICY

A special rate of \$50 per night is available for cabin rentals during Sunday through Thursday. If a cabin is rented for three consecutive nights anytime between Sunday through Thursday, you get a fourth night stay for free! The rental fee is \$70 per night during non-holiday weekends (Friday & Saturday). The minimum length of stay required is two nights. The rental fee during designated holidays is \$80 per night. A three night stay is required on designated holidays. The designated holidays are Memorial Day, Fourth of July and Labor Day. The weekly rental fee (7 nights) per cabin is \$350. **All reservations will also be charged a Iowa 5% motel tax on top of the rental fee. A \$100 damage deposit is also required for each cabin reservation. Renters may check in at 4:00 p.m. Renters are required to check out by 2:00 p.m. Should you decide to cancel, your rental fee payment will not be returned.**

After your stay is completed, HCCB staff will perform a routine inspection on the cabin(s) you rented. If you do not receive a phone call from us within one month after your stay, then HCCB will destroy your damage deposit check(s).

FURNISHINGS & CAPACITY

Each cabin features the following comforts of home: heat and air conditioning, electricity service, hot and cold running water, bathroom with toilet, sink and shower, kitchen area with sink, small gas stove and oven, small refrigerator with freezer, microwave and storage cupboards, ceiling fan, futon, futon chair and table with four chairs. Each cabin also has a mop, broom, dustpan, basic eating and cooking utensils and garbage cans. **Please note that the cabins DO NOT HAVE: pillows, bedding, blankets, cooking or camping supplies, kitchen linens, bath towels, personal hygiene products, firewood, phones and televisions.**

Sleeping accommodations include the use of one full-size bed with one twin bunk bed. Additional sleeping accommodations include one full-size futon per cabin. Each cabin can sleep 4-5 people.

Outdoor amenities include: 6' X 15' deck, picnic table, campfire ring and lighted and designated parking for two vehicles. One tent is allowed to be placed on the cabin grounds next to your cabin for an additional fee of \$15/night. To register a tent at your cabin, go to the campground registration building located near the park entrance.

NO SMOKING OR PETS ARE ALLOWED INSIDE THE CABINS.
